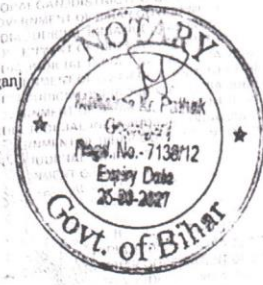

AFFIDAVIT



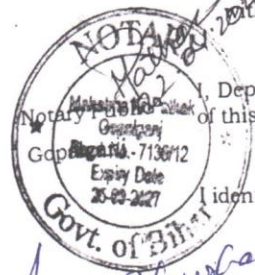
